PROGRAM

Goal: Increase participation in programs and activities of the members and other interested individuals and groups

Activities Program

The Activities Program provided many different activities that included exercise, language, games, meals, support groups, crafts, senior concerns, literary, social, and health related issues. There are approximately 184 different people who come to the Senior Center during a week. Potlucks were held every month.

The 2nd Annual Conference on Aging was held at Antioch University Midwest in October. Over 100 people participated.






Homemaker Program

The Homemaker Program receives funding support from Greene County Council on Aging's Partners in Care (PIC) program. Funding also comes from clients who are private pay. In 2017 the program served, on average, 54 clients per month. There were approximately 4,500 hours of homemaker services rendered in 2017.

Support Services Program

The Support Services Program receives funding support from Greene County Council on Aging. The average number of clients seen per month is 12-15. There are approximately 5-7 telephone calls received and/or made each day. At Medicare Open Enrollment there were approximately 28 people seen. We saved those clients \$40,225 through a review of their Medicare Part D Plans.

Transportation Program

The Transportation Program receives funding support from Greene County Council on Aging. There were 2,442 ride requests provided in 2017. There were 13,826 miles driven by over 30 volunteers, who averaged 110 hours per month. Of the rides given, 49% were to Senior Center programs, 30% were for medical appointments, and the remainder were for various reasons including grocery stores, personal care, and others. 71% of the rides were within Yellow Springs.

Miller Fellowship Program

The Senior Center had the services of Tabitha Drover, a Miller Fellow in 2017. The Miller Fellowship Program is an initiative of the YS Community Foundation. The purpose of the fund is to support fellowships for Antioch College students who engage in service for the benefit of the Yellow Springs community.

The Senior Center is very grateful for the work the Miller Fellow completed and to the YS Community Foundation for the funding.



Dementia Friendly Yellow Springs



In July 2017 an initiative to create Yellow Springs as a Dementia Friendly American Community was begun. Funding was received by The Dayton Foundation (Del Mar Senior Social Innovation Fund) and YS Community Foundation. The project is to be completed by December 2018. Yellow Springs will be one of the only 2 communities in Ohio to have the designation as a Dementia Friendly Community. Toni Dosik is the project manager and Kate LeVesconte is the project coordinator. In 2017 a community book read was completed. A kick-off breakfast was held that saw over 60 people in attendance from all over the county. The Conference on Aging had a theme of "Living in a World with Dementia." An advisory committee has been established with well over 20 members. Support for this initiative has been generously provided by Greene County Council on Aging.

STRUCTURE/INFRASTRUCTURE

Goal: Maintain and maximize the use of the current facility and explore the possibility of a new facility or alternative means for meeting the need for additional space

- ♦ The Center got an interior face lift. With funding from Greene County Council on Aging, LED bulbs were installed in all light fixtures.
- ♦ New dishwasher was installed in the Great Room kitchen.
- A new exterior door to the Great Room was installed.
